- Company trading and registered names and address.
- VAT registration number if applicable.
- Printed or scanned copies of letterhead and business cards.
- Directors names and applicants full name and position.
- · Company website and contact details.
- Industry body membership numbers where appropriate.

HOW IT WORKS:

- Available on all orders over £500 in total inc. VAT for your first order and over £250 for subsequent orders.
- Qualifying order value excludes third party costs where applicable such as insurance products, fitting charges, out of area delivery etc. Full details on our web site.
- Minimum 25% discount off of our non-event or top prices.
- Some products such as all clearance lines may be excluded from the discount scheme and excluded at short notice.
- · A minimum deposit of 50% is required for all items including curtains, blinds and flooring.
- Payment can be via card or bank transfer only.

OTHER CONDITIONS:

- The scheme is not available for any customers who may already have an outstanding order or quotation with us.
- Fishpools reserve the right to withdraw the trade discount scheme at any time without notice, in its entirety or from individual businesses.
- Payment must always be made in full by trade partners before we will release products for delivery/collection.
- · Existing free delivery programme conditions apply see delivery & postcode section of our website for details.
- Trade account orders are the sole responsibility of our trade partners, the orders will be in your name and we will not discuss these orders with your clients.
- · Deliveries must be signed for by the trade account holder or a representative authorised by the account holder.
- Returns can only be made if there is an issue of fault or damage. Hence trade partners must ensure that
 the product is suitable for their clients in every way and that it can be delivered without access issues. We
 cannot accept returned products simply because of access issues, a change of mind or differences you
 may have with your client.
- Should a product be damaged, your client should contact you and you should contact us. Where appropriate we will despatch a service technician to remedy the problem or recommend a resolution.
- Your orders should only be placed via email to trade@fishpools.co.uk.
- Cancellations of your orders once we have confirmed with our suppliers will incur a penalty charge of 50% of the retail value of the cancelled element.
